1. General Regulations

The **ROSTELECOM CUP** will be conducted in accordance with the ISU Constitution and General Regulations 2010, the Special Regulations & Technical Rules Single & Pair Skating and Ice Dance 2010, and the relevant ISU Communications.

Participation in the **ROSTELECOM CUP** is open to all Competitors who belong to an ISU Member, and qualify with regard to eligibility according to Rule 102, provided their ages fall within the limits specified in Rule 108, paragraph 2 b) and they meet the participation, citizenship and residency requirements in Rule 109, paragraphs 1 through 5 and ISU Communication 1420 or any update of this Communication.

In accordance with Rule 109 of the ISU General Regulations and ISU Communication 1420 all Skaters who do not have the nationality of the Member by which they have been entered or who, although having such nationality, have in the past represented another Member, must produce an ISU Clearance Certificate. Passports of all Skaters, as well as the ISU Clearance Certificate, if applicable, must be presented at the accreditation of the event for verification.

Entries can only be made through the ISU Members. With reference to the Announcement of the ISU Grand Prix of Figure Skating 2009/2010 the event is only open to invited competitors.

2. Technical Data

Place: main arena: Ice Palace“MEGASPORT”, Khoroshevskoye highway,38, Moscow
(an indoor ice-rink with the ice surface of 60 x 30 m , air-conditioned and heated);

Men: Short Program The prescribed elements to be skated are those listed in ISU Technical Rule Single and Pair Skating 2010, Rule 511, para 1 and 2 and the respective ISU Communication.
Duration: max. 2 min., 50 sec., but may be less

Free Skating In accordance with ISU Technical Rules Single and Pair Skating 2010, Rule 512 and the respective ISU Communication.
Duration: 4 min., 30 sec., +/- 10 sec.

Ladies: Short Program The prescribed elements to be skated are those listed in ISU Technical Rules Single and Pair Skating 2010, Rule 511, para 1 and 2 and the respective ISU Communication.

Duration: max. 2 min., 50 sec., but may be less

Free Skating In accordance with ISU Technical Rules Single and Pair Skating 2008, Rule 512 and the respective ISU Communication.
Duration: 4 min., +/- 10 sec.

Pairs: Short Program The prescribed elements to be skated are those listed in ISU Technical Rules Single and Pair Skating 2010, Rule 520, para 1 and 2, group for 2010/11 and the respective ISU Communication.

Duration: max. 2 min., 50 sec., but may be less;

Free Skating In accordance with ISU Technical Rules Single and Pair Skating 2010, Rule 521 and the respective ISU Communication.
Duration: 4 min., 30 sec., +/- 10 sec.

Ice Dance: Short Dance

In accordance with ISU Technical Rules Ice Dance 2010, Rule 609 and all pertinent ISU Communications.

The composition of the Short Dance in the season 2010/11 will contain 5 Required Elements in total:

2 Required Elements in the Pattern Dance part: **1** sequence of the Golden Waltz is divided into 2 sections and each of these sections is considered as one of the two Required Elements

3 Required Elements in the Creative part (Short Lift, Midline Not-touching Step Sequence and Set of Sequential Twizzles)

Music for the entire Short Dance (including music for specified Pattern Dance) is provided by the couple and may be vocal. The music for the specified Pattern dance must be within the announced tempo range (61-63 measures of 3 beats per minute).

The choreography of the Creative part may be to the same rhythm as the specified Pattern Dance (Waltz) or to one or two of the rhythms chosen from the following rhythms: Foxtrot, Quickstep and Tango which can be included in any order.

Duration: two (2) minutes and 50 seconds (plus or minus 10 seconds).

Free Dance

In accordance with ISU Technical Rule Ice Dance 2010, Rule 610 and all pertinent ISU Communication. For the value of the required elements and components see the respective ISU Communication.

Duration: 4 min. +/- 10 sec.

ISU Technical Rules Ice Dance 2010, Rule 610 paragraph 2 (required elements) and the respective ISU Communication must be observed.

3. **ENTRIES**

3.1 **Confirmation of Entries**

In accordance with the ISU Grand Prix of Figure Skating 2010/2011 announcement entries can only be made for skaters/couples who are qualified and/or selected for invitation. The confirmation of the entries must be submitted by **August 15, 2010** latest to

The official forms must be used. Changes or substitutions require the approval of the ISU Grand Prix Coordination Group.

3.2 Entries by Name

3.2.1 General

Entries by fax or e-mail must be confirmed by a letter sent out simultaneously to the Organizers (Rule 115, paragraph 5).

Each Entry Form must be signed by an authorized ISU Member Representative such as President, General Secretary, Executive Director, CEO (Rule 104, paragraph 4). For more details please refer to Rules 115, 131, 378 and ISU Communication No. 1628 or any update of this Communication.

The replacement of Competitors in the ISU Grand Prix of Figure Skating will be made in accordance with Paragraphs 3.5 and 7.6 of the Announcement for the ISU Grand Prix of Figure Skating 2010/2011.

3.2.3 Entries of Judges

An entry of competitor(s) is not automatically followed by an entry of a Judge. Participating ISU Members may be invited by the hosting Federation to nominate one or more Judges for one event. Any substitution or changes for any of the invited judges need the approval of the Figure Skating Federation of Russia.

Please observe the restrictions concerning the selection of Judges within the events of the ISU Grand Prix of Figure Skating 2010/2011 that no Judge may serve in more than two ISU Grand Prix events (Figure Skating and Ice Dance not separated).

Each panel of Judges will consist of a maximum of 9 Judges but with a minimum of 7 Judges, if possible.

4. **MEALS, LODGING and TRAVEL EXPENSES**

The organizer will provide and cover the expenses for rooms and meals for all Competitors and Judges participating, beginning with dinner from **November 17, 2010** until breakfast of **November 22, 2010**.

Should any Competitor or Judge arrive at the hotel before or stay longer than the period described above, their room costs and expenses will be the responsibility of the individual and must be paid on arrival, except if an arrangement has been made with the organizer.

The organizer will provide and cover the expenses for rooms and meals also for the Referees, the Technical Controllers, the Technical Specialists, the ISU Grand Prix Coordinator for the ISU Grand Prix of Figure Skating,

the Chair of Sports Directorate, the ISU Event Coordinator, the Data and Replay Operators, the Cameraman, the Technical staff of ST SPORTSERVICE and the Anti-Doping Control Team during the same period as indicated for the competitors. If any longer period is agreed upon with the Organizing Committee, the period of coverage will be prolonged as agreed.

The Organizing Committee will cover the airfare for all invited Competitors, Judges and the Anti-Doping Control Team from their domicile to Moscow.

The Figure Skating Federation of Russia is the only authorizing body of airline tickets. All participants must agree to the acceptance of the provided tickets when the invitation is accepted. No reimbursement will be made on any airline ticket issued by any other agency or any other airline unless written permission is received from The Figure Skating Federation of Russia prior to its ticketing.

All extra expenses incurred by any Team Member or any kind of Official will be the responsibility of that person and must be paid prior to departure.

The Judges, the Referees, the Technical Controllers, the Technical Specialists and the Data and Replay Operators will receive remuneration in accordance with ISU Communication No. 1401, paragraph II, I) (or any update of this Communication). The honorarium will be provided in hard currency. The remuneration will be paid upon accreditation.

5. PRACTICE

Official practice for Competitors begins on **November 18, 2010**. The detailed schedule will be issued at the time of registration. According to ISU Regulations 540 and 634 no competitor/couple may practice in a rink other than the official rink or rinks after having been accredited through the Organizing Committee.

6. MUSIC / PLANNED PROGRAM CONTENT

All Competitors shall furnish competition music of excellent quality on CD or MD format, in accordance with Rule 343, paragraph 1. A list of titles, composers and orchestras of the music to be used for the Short Program and Free Skating Program for Single and Pairs, for the Original and Free Dance Program for Ice Dance and for the Exhibition must be listed for each Competitor on the official Music Selection Form and attached to the official Entry Form for Competitors.

In accordance with Rule 343, paragraph 1, all discs must show the Competition event, Competitor's name, the Nation and the exact running time of the music (not skating time) including any starting signal and must be submitted at the time of registration. Each program (short program, free skating, original dance, free dance) must be recorded on a separate disc. In addition competitors/couples must provide a back-up drive for each program.

If music information is not complete and cassettes or discs not provided, accreditation will not be given.

With the entry forms, the "Program Content Sheet" must return to the Organizing Committee in time. It is mandatory that the Program Content Sheet must be filled in precisely by each Skater/team in English using the terminology for the elements listed in the respective ISU Communication.

It is not permitted to hand over the Program Content Sheets directly to the acting Officials.

7. ARRIVAL OF PARTICIPANTS / TEAMS

The participating Teams and all respective team-members as well as all Event Officials are requested to announce to the Organizing Committee as soon as possible but no later than September 25, 2010, the name of the airlines, flight numbers, dates and times of arrival, the name of airport or any other information concerning transportation and arrivals. The official "travel form" should be used.

The nearest airport to Moscow is Sheremetievo with a distance of hour to the official hotel. The Organizing Committee provides a bus shuttle to meet the teams on arrival. Please be informed that chaperons and all

other accompanying persons will only be included in the transportation, if space is available and they arrive with the team.

9. ACCREDITATION

The official accreditation is planned at the Aerostar Hotel upon arrival.

Accreditation will be given to appointed Event Officials, ISU Office Holders and Guests.

Accreditation as a Team Member will be given to all entered Judges, Competitors and one Team-Leader per participating team, one Coach per Competitor, a maximum of two Officials of ISU Members, provided that they are Council Members, Technical Committee Members or Members of the Head Office of their Federation and a maximum of two medical persons, for which the organizer requests the right to have a medical certification (document) presented before accreditation. Accreditation will only be granted to persons in those various functions if officially entered and named through their National Association. **The ISU Member certifies with the signed entry the indicated functions within the team of all team members. Any misuse of any function will be sanctioned by the ISU/OC.**

All persons mentioned on the delegation form (except those under G and H) must fill out the Declaration form as per ISU Communication No. 1628 and send it to the ISU Secretariat (declaration@isu.ch) at the latest 2 weeks before the start of the Event.

Chaperons will not receive accreditation. The Team Leader may request "bus permits" for the official registered Chaperons to join the official shuttle bus system of the Organizing Committee.

10. RESULTS

The marking system (ISU Judging System) as described in ISU Technical Rule Single & Pair Skating 2010, Rule 352 and Rule 353 (Determination and publication of results) will be used.

11. PRESENTATION OF MEDALS

The three best placed skaters/couples in each event will be announced and honoured. Gold, silver and bronze medals will be presented to the medallists. The national anthem of the winner will be played and the flags of the medal winners hoisted.

12. POINTS FOR "ISU Grand Prix of Figure Skating"

Points will be awarded as follows:

Men, Ladies, Ice Dance

1 st place	15 points
2 nd place	13 points
3 rd place	11 points
4 th place	9 points
5 th place	7 points
6 th place	5 points
7 th place	4 points
8 th place	3 point

Pairs

1 st place	15 points
2 nd place	13 points
3 rd place	11 points
4 th place	9 points
5 th place	7 points
6 th place	5 points

The points received are of value for the ISU Grand Prix of Figure Skating and the qualification for the ISU Grand Prix of Figure Skating Final.

If a skater/couple does not complete an event due to illness or injury, this event will be treated as "not skated", i.e. the result(s) of initial round(s) completed will not count for the Grand Prix ranking order. Such an event will however count as one participation but without receiving credit in the ranking order.

Additionally, it is understood that skaters who score points at an event will only score the points according to their respective placements as stated above.

The results of the event will count for the "ISU World Standings". (see paragraph 14)

13. PRIZE MONEY

The Global Prize Money per individual event of the ISU Grand Prix of Figure Skating will be:

Awarded to winners and placed skaters/couples as follows:

The individual prize money will be transferred to the ISU Members concerned immediately after the conclusion of the **ROSTELECOM CUP**.

Skaters/couples qualified for the exhibition must participate with an appropriate show number different from their competition programs. Failure to do so, will result in a reduction of USD \$ 3.000.00 from the awarded prize money.

Skaters/couples are expected to be ready for any ceremony and/or prize award and participate in press conferences and/or social events if asked by the ISU and/or the event's Organizer. Failure to do so may result in a reduction of awarded prize money. The decision to reduce prize money will be made by the assigned ISU Delegate attending the event, subsequently to be ratified by the Council.

The withholding tax will be deducted according to the actual government's law.

Exhibition Fee

An exhibition fee will only be paid to skates/couples who are not awarded prize money. The exhibition fee is set at USD\$200.00 for single skaters (Men and Ladies) and USD\$300.00 for Pairs and Dance couples.

14. ISU World Standings

World Standing points will also be awarded according to the "World Standings Procedure" that can be found on the ISU website (www.isu.org) under Single & Pairs/Ice Dance – World Standings."

15. ANTI-DOPING CONTROLS

Anti-Doping tests will be conducted at each of the six events of the ISU Grand Prix of Figure Skating as well as at the ISU Grand Prix of Figure Skating Final.

The Anti-Doping tests will be conducted in accordance with the current ISU Anti-Doping Rules & Procedures (ISU Communications No. 1603 and 1604 or any further update of this Communication).

The tests will be carried out on the winning skater/s in Singles (after the final Free Skating), Pair Skating (after the Free Skating) and Ice Dance (after the Free Dance). One skater from the remainder of the skaters shall be selected by random draw in Singles, Pair Skating and Ice Dance. In Pair Skating and Ice Dance, either the man or the lady, but not both, shall be tested and shall be selected by random draw.

16. INSURANCE / LIABILITY

In accordance with Rule 119, it is the sole responsibility of each Member participating in ISU Events, to provide medical and accident insurance for their athletes, officials and all other members of the Member's team. Such insurance must assure full medical attendance and also the return to the home country by air transport or by other expeditious means of the ill or injured person.

The ISU assumes no responsibility for or liability with respect to bodily or personal injury or property damage incurred in connection incurred by Competitors and Officials.
