

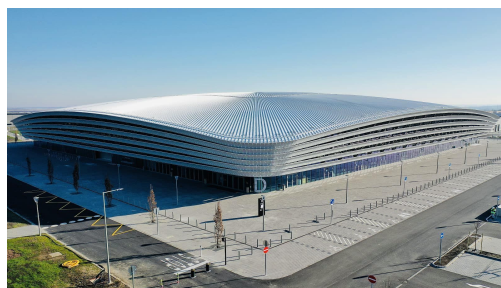

Date of the competition: 27-28th April, 2024.

Participants of the competition:

- Athletes with a MOKSZ membership, a valid competition license and a valid sports doctor's certificate
- the condition for participation is the submission of the entry and the payment of the entry fee by the specified deadline

Entry:

By entering the competition, competitors acknowledge that the organizer may conduct the competition in accordance with current health regulations and government regulations, and may unilaterally decide not to hold or limit the number of participants in the competition and to close the competition if the competition is closed. due to a pandemic situation or taking into account public health considerations, the holding of a sporting event is not safe or can only be held with the above restrictions. Competitors also acknowledge that the organizer may not hold a sporting event if this is prohibited by law for public health or other reasons. If the sporting event is not held due to the public health reasons specified in this section or due to a legal prohibition, the organizer cannot be held liable for any damages resulting from the non-performance of the sporting event. In the event of a sports event being missed in accordance with this section, the organizer is not obliged to set a new date for the sports event. The organizer reserves the right to make changes.

Competition rules:

NON-ISU Recreation and Adult Figure Skating Categories:

Figure skaters under the age of 9 (born after July 1, 2014) can compete in RECREATION, CUBS and CHICKS categories.

Age Group „B”: Born between 1 July 2011 and 30 June 2014 - Bronze and Silver categories.

Age Group „C”: Born on or after July 1, 2008 - Bronze, Silver and Gold categories

Age Group „D”: Born on or after 1 July 2005 - Bronze, Silver and Gold and Masters categories

II. Adult Figure Skating Categories:

Age Group „A”: Born after July 1, 1995 - Bronze, Silver, Gold and Masters

categories Age Group „B”: Born after July 1, 1985 - Bronze, Silver, Gold and Masters

categories Age Group „C”: Born after July 1, 1975 - Bronze, Silver, Gold and Masters

categories Age Group „D”: Born after July 1, 1965 - Bronze, Silver categories

Age Group „E”: Born before 1 July 1965 - Bronze, Silver categories

III. Adult Artistic Figure Skating Categories - Bronze level for all ages

Artistic Free Skating A - Born after July 1, 1995

Artistic Free Skating B - Born after July 1, 1985

Artistic Free Skating C - Born after July 1, 1975

IMPORTANT: Categories can be broken down for a large number of applications.



PROGRAM COMPONENTS:

- Skating Skills
- Performance / Execution
- Interpretation

REQUIREMENTS FOR ALL AGES:

Programs may include stage elements. It is allowed to use different accessories as long as they do not hinder the skater: eg hat, walking stick, scarf ... etc. Music can also be vocal.

Exceeding the length of the allowed music will be deducted 1 point every 5 seconds. Fall: 0.5 point deduction.

Factor number: 1.6

Free Skating Masters

A competitor in the Masters Free Skating event must perform a well-balanced program that may contain:

a) A maximum of seven (7) jump elements, one of which must be an Axel type jump. Single, double jumps are permitted. Triple jumps are not permitted.

b) There may be up to three (3) jump combinations or jump sequences in the free program.

- One (1) jump combination may consist of up to three (3) listed jumps.
- Two (2) jump combinations may consist of two (2) listed jumps.
- A jump combination may consist of the same or another single, double jump.
- A jump sequence may consist of two (2) jumps (single, double jump). It can start with any type of jump, from which the Axel jump must continue in a direct step.
- Only the two (2) highest value jumps count in the technical score.



- c) Each listed jump may be performed a maximum of two (2) times.
- d) A maximum of three (3) spins of a different abbreviation, one (1) of which must be a spin combination with a change of foot and one (1) of which must be a flying spin.
- e) The spins must have a required minimum number of revolutions: five (5) for the flying spin with no change of foot after landing, five (5) for the spin with only one position and no change of foot, five (5) for the spin combination with no change of foot, and eight (4 + 4) for the spin combination with change of foot or spin in one position with a change of foot.
- f) There must be a minimum of two (2) revolutions in each position or the position will not be counted.
- g) Spin combinations must include a minimum of two (2) different basic positions with two (2) revolutions in each of these positions anywhere within the spin. To receive full value, a spin combination must include all three (3) basic positions.
- h) A maximum of one (1) step sequence, fully utilizing the ice surface. Only the first executed attempt of a step sequence will contribute to the technical score.

Length of the program:

Recreation D Masters age group: 3 minutes 30 seconds +/- 10 sec.

Adult Masters A), B), C) age groups: 3 minutes +/- 10 sec. The result multiplier for the Masters categories is 1.6, the level of execution of the elements can reach a maximum of 4.

Free Skating Gold

A competitor in the Gold Free Skating event must perform a well-balanced program that may contain:

- a) A maximum of six (6) jump elements, consisting of single jumps (including the single Axel) or double jumps. Double Flip, double Lutz, double Axel and Triple jumps are not permitted.



b) There may be up to three (3) jump combinations or jump sequences in the free program.

- One (1) jump combination may consist of up to three (3) listed jumps.
- Two (2) jump combinations may consist of two (2) listed jumps.
- A jump combination may consist of the same or another single or double jump, with the exception of the jumps in bold above.
- A jump sequence may consist of 2 jumps (single and double jumps). It can start with any type of jump, from which the Axel jump must continue in a direct step.
- Only the two (2) highest value jumps count in the technical score.

c) Each listed jump may be performed a maximum of two (2) times.

d) A maximum of three (3) spins of a different abbreviation, one (1) of which must be a spin combination with a change of foot and one (1) of which must be a flying spin.

e) The spins must have a required minimum number of revolutions: four (4) for the flying spin with no change of foot after landing, four (4) for the spin with only one position and no change of foot and four (4) for the spin combination with no change of foot and eight (4 + 4) for the spin combination with change of foot or spin in one position with a change of foot.

f) There must be a minimum of two (2) revolutions in each position or the position will not be counted.

g) Spin combinations must include a minimum of two (2) different basic positions with two (2) revolutions in each of these positions anywhere within the spin. To receive full value, a spin combination must include all three (3) basic positions.

h) A maximum of one (1) step sequence, fully utilizing the ice surface. Only the first executed attempt of a step sequence will contribute to the technical score.

Length of the program:

The maximum time is 2 minutes 40 seconds +/-10 seconds.

The points for each Program Component are multiplied by a factor of 1.6.

Only features up to and including Level 3 will be counted for the spins and step sequence.



Free Skating Silver

A competitor in the Silver Free Skating event must perform a well-balanced program that may contain:

- a) A maximum of five (5) jump elements, consisting of any single jumps (including the single Axel). Double jumps and triple jumps are not permitted.
- b) There may be up to two (2) jump combinations or jump sequences in the free program.
 - One (1) jump combination may consist of up to three (3) listed jumps.
 - The other jump combination may consist of two (2) listed jumps.
 - A jump combination may consist of the same or another single jump.
 - A jump sequence may consist of 2 jumps. It can start with any type of jump, from which the Axel jump must continue in a direct step.
 - Only the two (2) highest value jumps count in the technical score.
- c) Each listed jump may be performed a maximum of two (2) times.
- d) A maximum of three (3) spins of a different abbreviation, one (1) of which must be a spin combination and another must be a flying spin.
- e). The spins must have a required minimum number of revolutions: three (3) for the flying spin with no change of foot after landing, three (3) for the spin with only one position and no change of foot and four (4) for the spin combination with no change of foot and eight (4+ 4) for the spin combination with change of foot or spin in one position with a change of foot.
- f) There must be a minimum of two (2) revolutions in each position or the position will not be counted.



g) Spin combinations must include a minimum of two (2) different basic positions with two (2) revolutions in each of these positions anywhere within the spin. To receive full value, a spin combination must include all three (3) basic positions.

h) A maximum of one (1) step sequence, fully utilizing the ice surface. Only the first executed attempt of a step sequence will contribute to the technical score.

Length of the program:

The maximum time is 2 minutes 10 seconds +/-10 seconds.

The points for each Program Component are multiplied by a factor of 1.6.

Only features up to and including Level 2 will be counted for the spins and step sequence. Any additional features will not count for level requirements and will be ignored by the Technical Panel.

Free Skating Bronze

A competitor in the Bronze Free Skating event must perform a well-balanced program that may contain:

- a) A maximum of four (4) jump elements, consisting only of single jumps. Axel type jumps, double jumps and triple jumps are not permitted.
- b) There may be up to two (2) jump combinations or jump sequences in the free program.
 - One (1) jump combination may consist of up to three (3) listed jumps.
 - The other jump combination may consist of two (2) listed jumps. A jump combination may consist of the same or another single jump.
 - A jump sequence may consist of jumps. It can start with any type of jump, from which the Axel jump must continue in a direct step.
 - Only the two (2) listed jumps with the highest value will count towards the technical score.
 - Each listed jump may be performed a maximum of two (2) times.



- c) A maximum of two (2) spins of a different abbreviation one of which must be a spin combination with no change of foot. Flying spins are not permitted.
- d) The spins must have a required minimum number of revolutions: three (3) for the spin in one position with no change of foot, four (4) for the spin combination with no change of foot and six (3+3) for the spin combination with change of foot or the spin in one position with change of foot.
- e) There must be a minimum of two (2) revolutions in each position or the position will not be counted.
- f) Spin combinations must include a minimum of two (2) different basic positions with two (2) revolutions in each of these positions anywhere within the spin.
- g) Only features up to and including Level 1 will be counted. Any additional features will not be counted for level requirements and will be ignored by the Technical Panel.
- h) A maximum of one (1) choreographic sequence fully utilizing the ice surface. A choreographic sequence consists of any kind of movements like steps, turns, spirals, arabesques, spread eagles, Ina Bauers, hydroblading, transitional (unlisted) jumps, spinning movements etc. The pattern is not restricted. A choreographic sequence has a base value and will be evaluated by the judges in GOE only.

Length of the program:

The maximum time is 1 minute 50 seconds +/- 10 seconds.

The points for each Program Component are multiplied by a factor of 1.6.

Artistic Free Skating

The freestyle of skaters starting in the Artistic Free Skating category will be judged by the judges based on the program components:

- Skating skills
- Transitions
- Performance / Execution



- Choreography / Composition

- Interpretation / Timing

Applicable Rules: Rule 504 (ISU Special Regulations and Technical Rules 2016, Singles & Pair Skating) § 3. No technical panel and technical score. Multiplier for program components: 1.0

The program in the “Artistic” category consists of various skating movements, the purpose of which is to express and convey the music much more than to show their technical difficulties. Competitors are scored based on their musical interpretation; the theme of the music, by their ability to skate their presentation is evaluated.

The points in the technical elements are based solely on how consistent the movements presented are with the music and the chosen theme. There is no separate point or evaluation for the level of technical implementation.

The program should be structured through the skating elements, the use of decorative - non-skating elements - kneeling, sharp steps should not be excessive, they should only emphasize the rhythm and character of the music. The skater must not stay still for more than five (5) seconds. Artistic Free Skating Competitions will be held at Bronze level only. The competition program for this category must include the following elements of the figure skating sport:

- Minimum one (1) and maximum two (2) single jumps,
- Axel, double or triple jumps and combinations are not allowed.
- Minimum one (1) and maximum two (2) rotations,

Any additional items (in addition to those specified above) will be considered illegal and 1.0 points will be deducted per error. If there is no jump or rotation item in it, a “1.0 item” will be deducted as 1.0 points.

Illegal items:

- somersault type jumps,
- Lying or kneeling on the ice for a long time.



It is the decision of the Arbitrator to apply the deductions. The suit should be simple, stylish and suitable for a sports competition. The costume should be chosen to adequately reflect the nature of the music and theme. Supplies should not be used in any part of the program. Any object that is held in the hand or removed from the garment during the performance is considered a prop. A hat worn during the program is not considered a prop, but if the presenter takes it off his head it is a prop.

Objects placed on ice, thrown into the public or placed in front of judges are also not allowed. No decorative elements (feathers, boa, pearls) are allowed on the garment that could sag.

It is the decision of the Arbitrator to judge the deductions due to this.

Length of the program:

Program length: 1 minute 40 seconds or less

Other provisions:

Everyone participates in the competition at their own risk and insurance, the organizer of the competition does not take any responsibility for any accident or injuries.

Together with the entry, the competitor acknowledges and agrees that a picture and sound recording will be made of it, the recorded recording can be used by the MOKSZ and the Székesfehérvári Jégmadár Figure Skating Club, which can be appear in the materials prepared for the media about the competition. Together with the entry, the competitor expressly consents to the processing of his/her personal data required for entry by the Székesfehérvári Jégmadár Figure Skating Club.

The purpose of data management is to register in the competition system and to administrate the results achieved in the competition. The data provided by the entry is handled by the Székesfehérvári Jégmadár Figure Skating Club in accordance with the legislation in force, especially in accordance with the provisions of the GDPR, the data may be forwarded to MOKSZ. The Székesfehérvári Jégmadár Figure Skating Club does not use a data processor.
